# Opposition ruled state machinery unfairly targets BJP workers & independent voices: JP NADDA

Opposition should adhere to political arguments, when questioned on their failing".



### Lockdown extends till May 31; MHA issues guidelines




Lockdown measures in place since March 24, 2020 have helped considerably in containing the spread of COVID-19. It has therefore been decided to further extend the lockdown till May 31, 2020.

Ministry of Home Affairs issued an order, under the Disaster Management Act, 2005, in this regard. The salient features of the new guidelines are as follows:

- Under the new guidelines, States and Union Territories (UTs) will now delineate Red, Green and Orange zones taking into consideration the parameters shared by the Health Ministry.
- All domestic and international air travel, Metro rail services, Running of schools, colleges, educational and training institutions, Hotels, restaurants, Social, political, cultural and similar gatherings and access to religious places are not permitted.
- However, online/ distance learning shall be permitted and encouraged; and, restaurants will be allowed to operate kitchens for home delivery of food items.



## HUGE PACKAGE AND NEW MSME DEFINITION WILL GIVE BIG BOOST TO INDUSTRY: GADKARI



Union Minister for MSME and Road Transport and Highways Shri Nitin Gadkari on 17 May said that the relief package announced by the Union Government for different sectors including MSME, labour, agriculture etc. and the new definition of MSMEs will give huge boost to industry.

- He called for exploring the rating of MSMEs and asked the participants to give suggestions for effective implementation of Fund of Funds announced as part of the package for MSMEs.
- Shri Gadkari said that there is need to explore Agro MSME and Fishing MSME sector.
- He urged the industry to maintain a positive attitude during these times to tide over the present crisis as negativity is not in anybody's interest.
- Recalling that Government of Japan has offered special package to its industries for taking out Japanese investments from China and move elsewhere, he opined that it is a good opportunity for India which should be grabbed.

# PHYSICAL DISTANCING AND BEHAVIOR ETIQUETTES ARE POTENT 'SOCIAL VACCINES' AGAINST COVID-19

Union Minister of Health Dr. Harsh Vardhan stated that "Our policy perseverance coupled with aggressive and early measures through a strong leadership have shown encouraging results".

- He added that the fatality rate has fallen to 3.1% and the recovery rate has improved to 37.5%.
- There are 3.1% active COVID-19 patients in ICU, 0.45% on ventilators and 2.7% on oxygen support".
- As on 17th May, a total of 90,927 cases have been reported from the country in which 34,109 persons have been cured and 2,872 deaths had occurred.
- The testing capacity has increased in the country to 1,00,000 tests per day through 373 Government laboratories and 152 private laboratories.
- As of now 916 dedicated COVID hospitals with 1,80,473 beds and 2,044 dedicated COVID Health Centres with 1,28,304 beds along with 9,536 quarantine centres and 6,309 COVID Care Centres with 5,64,632 beds are now available to combat COVID-19 in the country.

## TDB approves technologies to augment India's efforts to combat COVID 19

Technology Development Board, a statutory body of the Department of Science and Technology (DST), is proactively supporting the efforts of the scientists, technologists, entrepreneurs, and industrialists towards preventing and containing the spread of the COVID 19 pandemic by providing financial support for commercialization of these technologies.

- In the last few weeks, TDB has processed a large number of applications and approved six projects towards commercialization, which include thermal scanners, medical devices, masks, and diagnostic kits.
- TDB approved financial assistance to Latome Electric India, Coimbatore to produce battery-powered portable X-ray machines with digital display as standalone medical radiography equipment suitable for ICU & Isolation Wards.
- Financial support has been provided to Thincr Technologies India Pvt. Ltd, Pune, which is providing coating and 3D printing of anti-viral agents on the masks as a preventive measure against COVID-19. Kits
- Medzome Life Sciencez, New Delhi got support to manufacture fluorescencebased Rapid COVID-19 Detection Kit. KAMAL
